

**Minutes of the DDC Meeting with all Heads of Departments held on 7/3/2017 at 11.00 AM in the Conference Hall of Deputy Commissioner, Hailakandi.**

The meeting was presided over by Shri Arunava Dey, ACS, District Development Commissioner, Hailakandi.

At the outset, the District Development Commissioner welcomed all the members present in the meeting and narrated, at length, the purpose of the meeting.

Thereafter, Department-wise and scheme-wise discussions were held as under :-

1. **PWD (Rural Road)** : The Executive Engineer, PWD(RR), Hailakandi reported that all the works of PMGSY schemes are in progress, but some schemes may not be completed within 31<sup>st</sup> March, 2017. He also stated that most of the schemes under Assam Road Maintenance fund are in progress and will be completed within 31<sup>st</sup> March'2017. The schemes under RIDF are also going on in full swing. The District Dev Commissioner, Hailakandi directed the Executive Engineer, PWD(RR), Hailakandi to submit the latest status report of all works/schemes before the next DDC meeting to be held on 12/04/2017.
2. **PWD (National Highway)** : The Asstt. Executive Engineer, PWD(NH) informed that the Land Acquisition payment including Forest compensation for 67/600 KM to 89/00 KM in the southern part of Hailakandi District has already been deposited with the Deputy Commissioner, Hailakandi. Process of LA payment to the beneficiaries to be made early to get land cleared by the occupants so that balance work may be started soon, the house observed.
3. **PWD (State Road)** : In reply to a query regarding Matijuri Bridge at Hailakandi Duarbond Road - the AEE, PWD(SR), Hailakandi informed that the bridge is on the verge of collapse. The Chairman Cum District Development Commissioner directed to stop plying of all types of Vehicles, with proper signees and alternative arrangement should be made for University Students, Medical Patients etc. immediately.
4. **PWD (Bldg)** : In reply to a query, the AEE, PWD(Bldg), Hailakandi informed that the construction works of I.T.I. is 63% completed and assured that both I.T.I. & Judicial Building will be completed by March, 2017. He also stated that works of DIET is almost complete. District Dev Commissioner asked the AEE, PWD(Bldg) to expedite the construction works of Circle office at Lala and complete the work without any further delay and asked to ensure quality of work in respect of water tap and electrical fittings etc.
5. **AGRICULTURE** : The District Agriculture Officer, Hailakandi informed that Annual Action Plan, DIP, PMKSY 2017-18 is to be submitted as all concerned Department have submitted their plan. The Irrigation deptt has submitted their plan in the format other than prescribed one. The District Development Commissioner has instructed E E, Irrigation to submit the Plan in prescribed format by today.
